The Region of Murcia is located in the southeast of Spain and borders Andalusia, Castilla-La Mancha and Valencia. It has a dry Mediterranean climate the average annual temperature is 15°C to 18°C according to areas. The territory of Murcia easily passes from arid areas located in the basins of the south of the peninsula to the meadows formed by the Segura River and from there to the Mediterranean Sea.



The total population of the Region of Murcia is 1.531.878 inhabitants (INE 2022). The region is one of the largest producers of fruits, vegetables and flowers in Europe. It also has an important tourism sector. Its industry stands out for the petrochemical and energy sector, centered in Cartagena, and the food industry.

IMPEL organises its work into five thematic areas/expert teams:

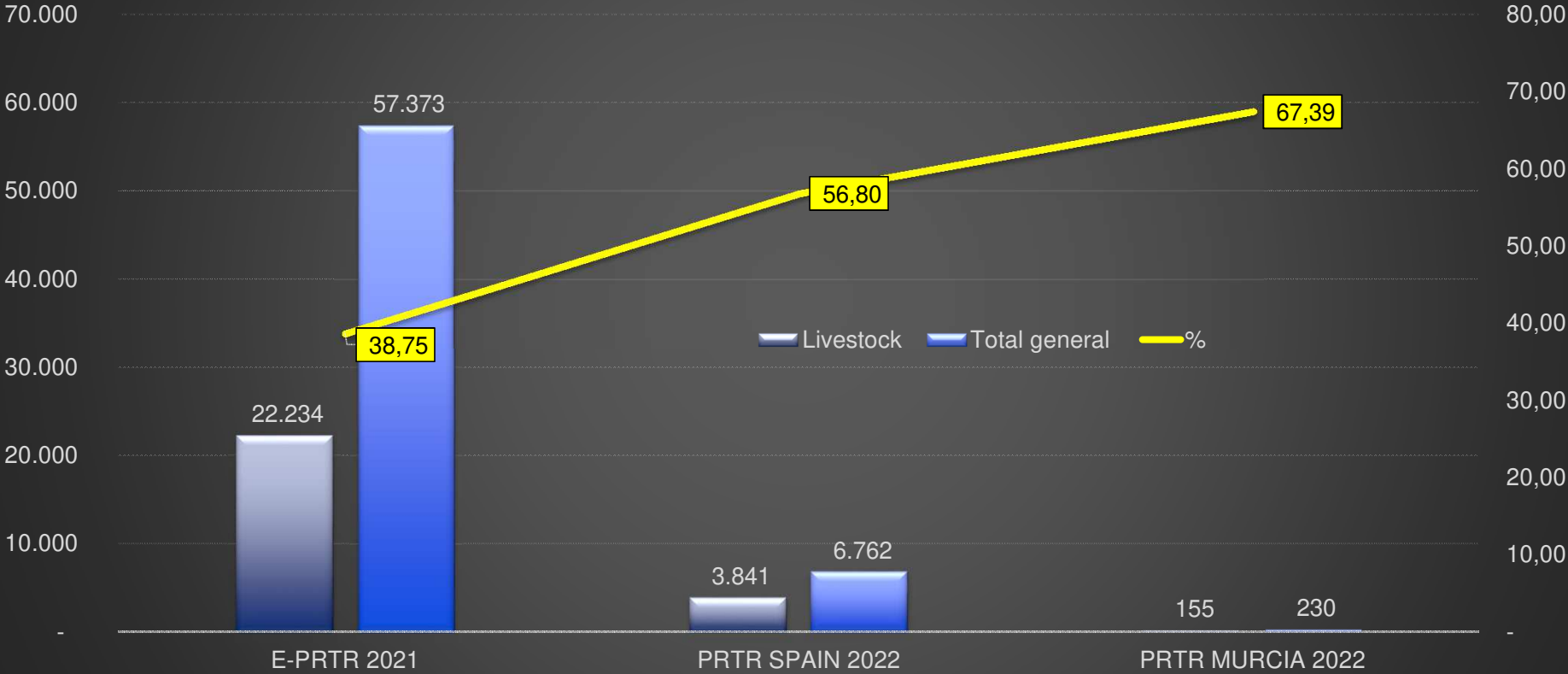
- 1. Industry and Air,**

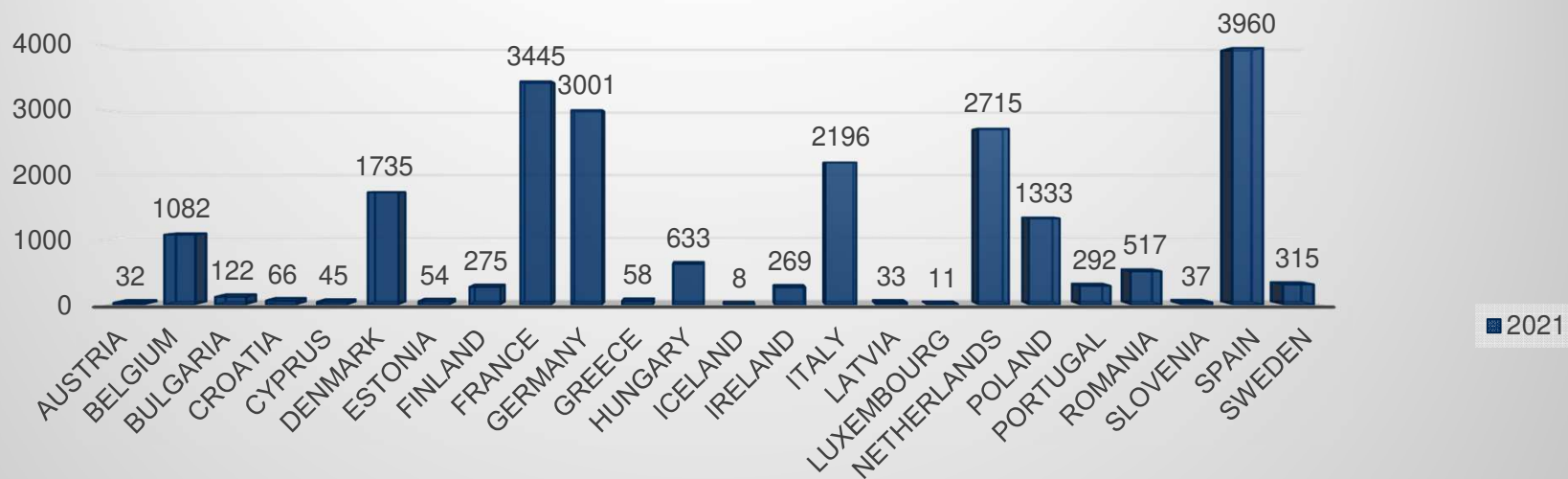
Since IMPEL's set up in 1992, more than 100 projects have been completed and various guidance materials, manuals, and tools have been produced.

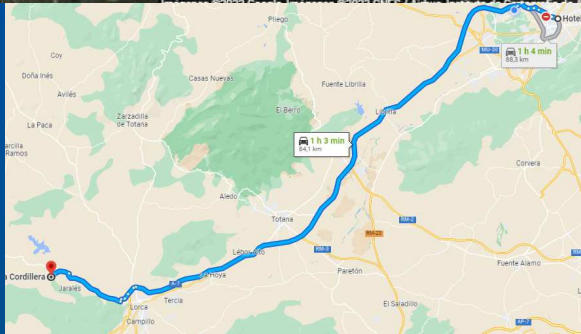
